ORDER

Heard learned counsel for the petitioner, Mr. K.M. Nataraj, learned Additional Solicitor General (A.S.G.) for the respondent-State and Mr. Sanjay Hegde, learned senior counsel for the applicant of I.A. No.301315 of 2025, who has sought intervention/impleadment in the present petition.

- 2. I.A. No.301315 of 2025 has been filed by the applicant seeking intervention in the present petition.
- 3. Having gone through the I.A. No.301315 of 2025 and averments made thereon, we think that the material brought on record are important for consideration of the present issue for which, Mr. Dishesh Aggarwal, A.D.C.P. (Officer in charge) and Mr. Indramani Patel, S.H.O. of the concerned police station, have been called before the Court.
- 4. For reasons aforesaid, the I.A. No.301315 of 2025 is allowed subject to all just exceptions.
- 5. Accordingly, the applicant is impleaded as respondent no.2.
- 6. We have gone through the affidavit filed on behalf of Mr. Dishesh Aggarwal, A.D.C.P. (Officer in charge) and Mr. Indramani Patel, S.H.O. of the concerned police station in terms of our previous order dated 04.11.2025.
- 7. As serious issues which relate to the basic and core issue of conduct of the police under the ostensible authority of the office/position held by them which has a direct bearing on the

confidence of the public have been raised in the I.A. No.301315 of 2025, copy of which has already been served upon the respondent-State, the Court would require the present two officers namely, Mr. Dishesh Aggarwal, A.D.C.P. (Officer in charge) and Mr. Indramani Patel, S.H.O., to also be impleaded as party respondents no.3 and 4.

- 8. As the stand taken by the A.D.C.P. is that the facts which have been disclosed in the I.A. No.301315 of 2025 have been brought to his notice only yesterday, he submits that he would be forwarding it immediately to the immediate superior, the D.C.P. as also, to the Commissioner of Police, Indore.
- 9. In view thereof, let the Commissioner of Police, Indore be also impleaded as respondent no.5, by his/her post.
- 10. Cause title be amended accordingly.
- 11. Let the newly added respondents file their personal affidavits with regard to the larger issue as also, with regard to all the averments which have been made in I.A. No.301315 of 2025.
- 12. List on 09.12.2025, retaining its position.
