

Court *vide* order dated 20th August, 2025, which is the subject matter of challenge in this appeal by special leave.

5. Considering the facts and circumstances of the case and more particularly the period of incarceration undergone by the appellant, which is nearly three years and since, hearing of the appeal is unlikely in the near future. We are inclined to accept the prayer made by the appellant.

6. We, therefore, suspend the sentences and direct that the appellant shall be released on bail during pendency of the appeal before the High Court on such terms and conditions as may be imposed by the trial Court.

7. The appeal stands allowed, accordingly.
