1. Leave granted.

2. Appellant who has been arraigned as an accused for the offence punishable under Section 21(C)/29 of Narcotic Drugs and Psychotropic Substances Act, 1985 (NDPS Act) is before this Court seeking for grant of regular bail after having suffered the order of rejection before the Courts below.

4. In that view of the matter, without expressing any opinion on the merits of the case, we allow this appeal by setting aside impugned order. The appellant is directed to be released on bail on such terms and conditions as the jurisdictional court may deem fit. Ordered accordingly.
