ORDER

Devan Ramachandran,J.

The learned Government Pleader has made available a report of the Station House Officer, Kalamassery Police Station. The report says that the appropriate authority has filed a complaint before the Judicial First Class Magistrate Court, Kalamassery; but that further investigation has not been commenced, awaiting orders. It further says that from the available investigation conducted, various unlawful activities like online advertisements offering remuneration; inducing victims for egg donation and surrogacy etc, have been detected – through which victims have been lured.

2. Our order of 29.09.2025, along with the one dated 17.10.2025, clearly prepares the ground for the investigating officers.

3. We have little doubt that the investigation must be conducted strongly and that the Police and the authorities need not wait for orders from the Judicial Magistrate of the First Class for such purpose, except with respect to the aspects that have

been impelled before it.

4. We are, therefore, of the view that a special investigation team should be now constituted so that all aspects can be properly considered.

5. We direct the learned Government Pleader to obtain specific instructions from the State Police Chief in this regard and inform us on the next posting date.
