UPON hearing the counsel the Court made the following

O R D E R

1. The petitioner challenges the judgment and order dated 21.11.2025 in CRMM No.41862/2025 (O&M) titled "*Harjit Kaur @ Harjeet Kaur vs. State of Punjab & Anr.*" passed by the High Court of Punjab & Haryana at Chandigarh.

2. Complainant-Ms. Kamlesh, W/o S. Gurnail Singh and D/o S. Piara Singh, R/o H.No. 155, City Enclave, Mehmoodpura, Ludhiana is impleaded as a party-respondent. The cause title be amended accordingly.
3. Issue notice, returnable on 13.02.2026.
4. Ms. Abha Sharma, learned Advocate on Record accepts notice on behalf of the State. Let notice be issued to the newly impleaded respondent.
5. Dasti service, in addition, is permitted. Let steps for service be taken within one week.
6. In the notice itself, let it be mentioned that respondent is required to file a counter affidavit and reply to the interlocutory application(s), if any, before the next date of listing.
7. In the event of arrest, the petitioner in connection with F.I.R. No. 67 dated 13.06.2025, registered under Sections 419, 420, 120-B, 465, 467, 468 and 471 of IPC, Police Station Division No.2, District Police Commissionerate, Ludhiana shall be released on bail by the Investigating/Arresting Officer on such terms and conditions as may be imposed and found to be just, fair and reasonable.
8. Needless to add, the petitioner would maintain good conduct and not attempt to influence any of the witnesses, in any manner, till the completion of the trial.

9. Let counter affidavit by the State be filed within two weeks.
Rejoinder thereto, if any, be filed within one week thereafter.
