NOTIFICATION

Whereas the draft of the Karnataka Excise (Excise Duties and Fees) Rules, 1968, was published as required by sub-section (1) of section 71 of the Karnataka Excise Act, 1965, (Karnataka Act 21 of 1966) in Notification No. FD 04 PES 2020, dated: 18.03.2020 in Part IV A of the Karnataka Gazette No.1212, dated:19.03.2020 inviting objections and suggestions from all persons likely to be affected within seven days from the date of its publication in the official Gazette.

And, whereas the said Gazette was made available to the public on $19^{\rm th}$ March 2020.

And, whereas no objections and suggestions were received in respect of the said draft by the StateGovernment.

Now, therefore, in exercise of the powers conferred by Section 71 of the Karnataka Excise Act, 1965, (Karnataka Act 21 of 1966) the Government of Karnataka hereby makes the following rules, namely;

RULES

1. <u>**Title and commencement**</u>:- (1) These rules may be called the Karnataka Excise (Excise Duties and Fees) (Amendment) Rules, 2020.

(2) They shall come into force with effect from the 1st day of April, 2020.

2. <u>Amendment of Schedule-D</u> :- In the Schedule-D to the Karnataka Excise (Excise Duties and Fees) Rules, 1968, for Serial Number I and the entries relating thereto, in corresponding columns, the following shall be substituted, namely:- BOOK
