Sir/Madam,

I am directed to refer this Ministry's letter No. J-11012/02/2016 RH dated 21st July, 2017 (copy enclosed) regarding display of Logo of PMAY-G and other details on the completed houses for identification of houses constructed under this scheme.

- 2. In this regard, it is stated that during the visits to completed houses and upon random checking of photos of completed houses, as available on AwaasSoft, upon random checking of photos of completed houses, as available on AwaasSoft, it has been observed that in many cases either the Logo of PMAY-G is missing from the completed house or when found in many cases it does not match with the official logo of PMAY-G. Further, it has also been observed that the logo of PMAY-G used during various functions, campaigns etc., organised by the State/UT Governments, does not match the official logo of PMAY-G.
- 3. Considering the above, the official Logo of PMAY-G has been uploaded on the website of PMAY-G (http://pmayg.nic.in/netjay/images/pmay-g-logo.png) from where the same can be accessed/ downloaded.
- 4. It is requested that necessary instructions may be issued to all the officials involved in the implementation of PMAY-G to ensure that the official logo, uploaded on the website of PMAY-G, only be used for all the purposes pertaining to the scheme of PMAY-G.
