Finance Expenditure approved Whereas the No. CAU/Reg/584/Ord/05/ Committee Memo along with addendum in respect of the sanction of the Central Agricultural University Scheme under the VIIIth Five Year Plan as communicated by the Joint Secretary Department of Agricultural Research and Education and Secretary, Indian Council of Agricultural Research vide their letter number 1(2)/92-PI and M (Part-III) dated 13<sup>th</sup> October, 1993 provides for the establishment of the Central Agricultural University for North-Eastern Region with headquarters at Imphal (Manipur) having office of the Vice-Chancellor; Directorates of Instruction. Research and Extension Education, etc. and with College of Agriculture (Manipur), College of Veterinary Sciences (Mizoram), College of Agricultural Engineering and Post Harvest Technology (Sikkim), College of Horticulture and Forestry (Arunachal Pradesh), College of Fisheries (Tripura), College of Post-Graduate Studies and College of Home Science (Meghalaya) in the States of the North-Eastern Region as mentioned in respective parentheses:

And whereas, the aforesaid sanction also provides for creation and filling of the Academic positions, such as the Director of Instruction, Director of Research and Director of Extension Education, Deans of the concerned Colleges and of Professors. Associate Professors and Assistant Professors and their equivalent academic positions.

And whereas, the Government of India in the Department of Agricultural Research and Education/Indian Council of Agricultural Research has approved the issue/making of an Ordinance prescribing the academic and other qualifications for the various academic

and scientific positions for the Central Agricultural University vide letter No. 42(1)/94-Edn/IV dated 8<sup>th</sup> August, 1994.

And whereas, in exercise of the powers conferred by sub-section 2 of 27 of CAU Act, 1992 (No. 40 of 1992) and sub-section (1) of Section 40 of the Statutes of Central Agricultural University Act, 1992 (No. 40 of 1992), the Board of Management of Central Agricultural University approved the amendments regarding the experience/qualification of the posts of Deans/Directors(Instruction/Extension Education/Research). Professors, Associate Professors and Assistant Professors and their equivalent academic positions in Ordinance No. 5 of 1994.

Now, I, S.N. Puri, Vice-Chancellor, Central Agricultural University, Imphal in exercise of powers conferred by sub-section 2 of section 27 of C.A.U.
